Responsible pricing for our life-changing treatments enables us to help to reduce pressures on patients in need and the health-care systems who take care of them, whilst maintaining sustainable investment in research & development (R&D) to drive future innovation. It also allows us to continue investing in ongoing clinical trials for existing, authorized treatments to provide additional data on the value of these treatments. Whether we are bringing new innovative treatments to people with limited treatment options, or bringing existing treatments to patients in different countries, we aim for fair and sustainable pricing that maximizes access for patients who can benefit from our treatments.

How treatment pricing is set rightly continues to come under global scrutiny. At UCB, we believe that thoughtful pricing based on the real value the treatment brings can help support not only widespread access but also equity in access. UCB recognizes that our pricing decisions not only impact patients, but also health-care systems and society at large. As one partner in complex health environments, we collaborate with health-care systems to strike a balance of flexible and reactive pricing, always ensuring that our prices enable UCB to achieve our core mission: provide solutions to patients that need them while ensuring long-term sustainability and benefit to the health-care system and society as a whole.

UCB's Approach

We design and build our pricing policies with patients and health-care systems in mind, supporting sustainable structures that can continue to create value. To achieve this, we use a bespoke, value-based pricing framework which looks at patient value in the context of individual health-care systems which patients use to access care. We use insights from patients about their experiences alongside other measures to truly understand a treatment's value. This structured approach analyses the value that each of UCB's treatments bring, measuring improvements in indicators such as patients' quality of life and treatment efficacy.



We recognize that different countries around the world face very different challenges, so UCB also takes these unique considerations into account. Our dedicated teams work closely with health-care systems and payers to ensure our product pricing is adapted to support different systems. As we come together to improve patient outcomes around the world, we also look further and consider the impact of pricing on patients.

Affordability of Medicines

At UCB, we want the result of our innovations to be accessible to all patients who need them. While there is not one single approach that suits all health-care systems, there is a universal need to promote equitable access to effective treatments. By adapting our pricing strategy to the particular challenges and patient populations of each country, we can better ensure that our innovations are accessible to all patients who need them. This enables us to offer medicines to those patients who would not otherwise be able to access treatment, as well as reduce unavailability of life-changing treatments. Our focus is to help patients to live as free as possible from the challenges and uncertainty of diseases, so we seek to negotiate pricing that is affordable, while maintaining a focus on sustainability and quality of our treatments to ensure long-term access for patients.

As we consider affordability for health-care systems, UCB is also considering the impact on patients. As such, UCB uses tools to assess affordability, including taking account of the amount individual patients may have to contribute towards the cost of the medicine, in order to set fair and sustainable prices.
