



## Transparency notification BlackRock, Inc.

**Brussels (Belgium), 30 September 2024 – 20:00 (CEST) – Regulated information**

### **1. Summary of the notification**

Pursuant to Article 14 of the law of 2 May 2007 on the disclosure of large shareholdings, UCB SA/NV announces that it received a transparency notification from BlackRock, Inc. (having its registered office at 50 Hudson Yards, New York, NY, 10001, U.S.A.), on 25 September 2024.

BlackRock, Inc. notified that, following a disposal of UCB shares with voting rights by its affiliates, its shareholding in UCB SA decreased and crossed the 5% threshold downwards on 24 September 2024.

On 24 September 2024, BlackRock, Inc. (taking into account the holding of its affiliates) owned 9 686 622 UCB shares with voting rights or assimilated financial instruments, representing 4.98% of the total number of shares issued by the company (194 505 658), versus 5.08% (9 890 529 UCB shares or assimilated financial instruments) in the previous notification dated 24 September 2024.

- **Reason for the notification:** Acquisition or disposal of voting securities or voting rights.
