



# U.S. District Court confirms validity of patent for UCB's Vimpat<sup>®</sup>

• Delaware District Court rejects challenge to patent claims

**Brussels (Belgium), 14 August 2016** – UCB announces today that the Delaware District Court confirmed the validity of U.S. patent RE38,551 related to Vimpat<sup>®</sup> (*lacosamide*), UCB's anti-epileptic drug.

"We are pleased with Delaware Chief Judge Stark's decision," said Anna S. Richo, Executive Vice President & General Counsel at UCB. "This confirms the strength of our intellectual property for Vimpat<sup>®</sup>."

This decision supports UCB's commitment to epilepsy patients and UCB's ability to deliver Vimpat<sup>®</sup> to patients. The decision is currently under seal and will be released following an order from the court.

Lacosamide (tradename Vimpat<sup>®</sup>) is approved as adjunctive therapy for the treatment of partial-onset seizures in adults with epilepsy (ages  $\geq$  17 years in the U.S., ages  $\geq$  16 years in the EU) and in the U.S. also as monotherapy. In the EU, Lacosamide is not currently approved for use as monotherapy. Lacosamide is currently available in 47 countries.
