



## Transparency notification BlackRock, Inc.

- **Notification referring to situation on 27 August 2019**
- **Threshold crossed: 5%**
- **Latest holding: 5.28 %**

**Brussels (Belgium), 3 September 2019 – 20:00 (CEST) – regulated information**

### 1. Summary of the notification

Pursuant to Article 14 of the law of 2 May 2007 on the disclosure of large shareholdings, UCB SA/NV announces that it has received a transparency notification from BlackRock, Inc. (having its registered office at 55 East 52nd Street, New York, NY, 10055, U.S.A.), dated 28 August 2019.

BlackRock, Inc., has notified that, following an acquisition of UCB shares with voting rights, its holding of UCB shares with voting rights has increased and has crossed the 5% threshold on 27 August 2019.

On 27 August 2019, BlackRock, Inc. (taking into account the holding of its affiliates) Inc. owned 9 871 847 UCB shares with voting rights (versus 9 645 034 shares in its previous notification), representing 5.08% of the total number of shares issued by the company (194 505 658) (versus 4.96% in its previous notification), as well as 400 554 equivalent financial instruments (versus 403 102 in its previous notification) representing 0.21% of the total number of shares issued by the company (same % as in its previous notification).
