1. Summary of the notification

Pursuant to Article 14 of the law of 2 May 2007 on the disclosure of large shareholdings, UCB SA/NV announces that it received a transparency notification from FMR LLC. (having its registered office at The Corporation Trust Center, 1209 Orange Street, Wilmington, New Castle County, Delaware, 19801, U.S.A.) on 19 April 2024.

FMR LLC., notified that, following an acquisition of UCB shares with voting rights by its affiliates, its shareholding in UCB SA increased and crossed the 7,5% threshold on 16 April 2024.

On 16 April 2024, FMR LLC. (taking into account the holding of its affiliates) owned 14.617.221 UCB shares with voting rights, representing 7,52% of the total number of shares issued by the company (194 505 658), versus 7,28% (14.155.080 UCB shares) in the previous notification dated 11 April 2024.
