



Transparency notification

Brussels (Belgium), 9 January 2017 – 19:30 (CET) – regulated information

1. Summary of the notification

Pursuant to Article 14 of the law of 2 May 2007 on the disclosure of large shareholdings, UCB SA/NV announces that it has received a transparency notification dated 30 December 2016, from BlackRock, Inc. (having its registered offices at 55 East 52nd Street, New York, NY, 10055, U.S.A.).

BlackRock, Inc. has notified that, following an acquisition of UCB shares with voting rights by its affiliates, its shareholding in UCB SA/NV had increased and has crossed the 3% minimum threshold.

On 29 December 2016, BlackRock, Inc. (taking into account the holding of its affiliates) owned 5 923 369 UCB shares with voting rights (versus 5 742 848 UCB shares in its previous notification dated 15 December 2016), representing 3.05% of the total number of shares issued by the company (194 505 658) (versus 2.95% in the notification dated 15 December 2016).

2. Content of the notification
