



Transparency notification Wellington

Brussels (Belgium), 23 August 2017 – 20:00 (CEST) – regulated information

1. Summary of the notification

Pursuant to Article 14 of the law of 2 May 2007 on the disclosure of large shareholdings, UCB SA/NV announces that it has received a transparency notification dated 18 August 2017 from Wellington Management Group LLP (having its registered offices at 280 Congress Street, Boston, MA 02110, USA).

Wellington Management Group LLP has notified that, following a disposal of UCB shares with voting rights by its affiliates, its shareholding in UCB SA has decreased and it has crossed downwards the lowest threshold of 3% on 16 August 2017.

On 16 August 2017, Wellington Management Group LLP (taking into account the holding of its affiliates) owned 5 118 453 UCB shares with voting rights (versus 5 909 710 shares in its previous notification dated 27 February 2017), representing 2.63% of the total number of shares issued by the company (194 505 658) (versus 3.04% in the notification dated 27 February 2017).

2. Content of the notification

The transparency notification dated 18 August 2017 includes the following information:

- Reason for the notification:
 - Acquisition or disposal of voting securities or voting rights;
 - Downward crossing of the lowest threshold.
- Notification by: A parent undertaking or a controlling person.
- Person subject to the notification requirement: Wellington Management Group LLP, 280 Congress Street, Boston, MA 02110 (USA).
- Date on which the threshold is crossed: 16 August 2017.
- Threshold crossed (in %): 3%.
- Denominator: 194 505 658.
