



Transparency notification

Brussels (Belgium), 13 July 2018 – 20:00 (CEST) – regulated information

1. Summary of the notification

Pursuant to Article 14 of the law of 2 May 2007 on the disclosure of large shareholdings, UCB SA/NV announces that it has received a transparency notification dated 9 July 2018 from BlackRock, Inc. (having its registered office at 55 East 52nd Street, New York, NY, 10055, U.S.A.).

BlackRock, Inc. has notified that, following an acquisition of UCB shares with voting rights and equivalent financial instruments by its affiliates, its shareholding in UCB SA has increased and has crossed the 5% threshold on 6 July 2018.

On 6 July 2018, BlackRock, Inc. (taking into account the holding of its affiliates) owned 8 982 056 UCB shares with voting rights (versus 8 780 237 shares in its previous notification dated 3 July 2018), representing 4.62% of the total number of shares issued by the company (194 505 658) (versus 4.51% in the notification dated 3 July 2018) as well as 803 011 equivalent financial instruments (versus 779 207 in its previous notification dated 3 July 2018) representing 0.41% of the total number of shares issued by the company (versus 0.40% in the notification dated 3 July 2018).

2. Content of the notification
